New Options Available for Pre-Authorized Payment Plans

Pre-Authorized Payments – 12 month installment option available January 2018

As of January 2018 we will be offering a 12 month installment option for our pre-authorized payment plans. This option is being offering in addition to the installment due date plan, and the PAPI0 program that runs from January – October. The 12 month option will allow for tax payment withdrawals to be directly deducted from your bank account on the 15th of each month from January to December. WHERE DO I PUT MY LEAVES ?

As the leaves start falling please remember that leaves are **NOT** to be placed at the street. There is NO street collection of leaves in the Township.

There are Yard Waste Depots where you can take your brush, leaf and yard waste.

Innerkip - Corner of George and Main Streets

Hickson - 158 Loveys St

Tavistock - 18 Hendershot St

Acceptable material

- Grass
- Leaves
- Halloween pumpkins
- House & garden plants
- Hedge & tree trimming
- (less than 7cm in diameter)

Acceptable Brush Waste

- Brush (Limbs/stumps longer than 6 foot/1.8m)
- Christmas trees

Also please be sure to keep the top of the storm drains clear. When they are covered with grass and leaves it prevents water from draining away. In order to help prevent a water build up on your property please remember to remove built up debris off the top.

Beat the Silent Killer

It is now the law in Ontario to install carbon monoxide (CO) alarms in your home if you have a fuel-burning appliance or an attached garage.

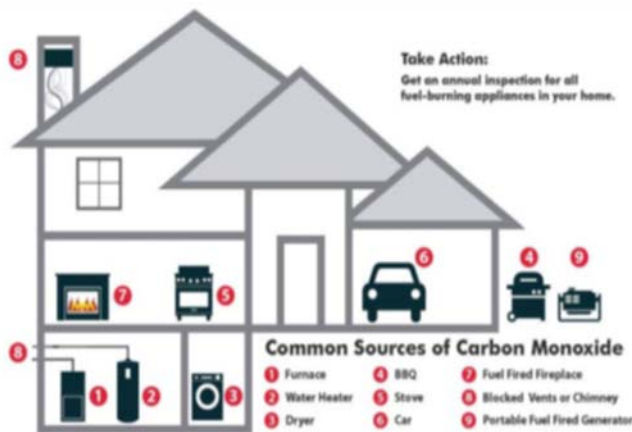
“If your home has a fuel-burning appliance or an attached garage, you must have a working CO alarm adjacent to each sleeping area of the home,” said EZT Fire Chief, Scott Alexander. “For added protection, install a carbon monoxide alarm on every storey of the home according to manufacturer’s instructions.” Fuel-burning appliances can include furnaces, hot water heaters, gas or wood fireplaces, portable fuel-burning heaters and generators, barbeques, stoves and vehicles.

Failure to comply with the CO alarm requirements could result in a fine of up to \$50,000 for individuals or \$100,000 for corporations.

The Ontario Fire Code was amended October 15, 2014 to require CO alarms after the provincial government passed Bill 77 – the Hawkins Gignac Act, in December 2013. Bill 77 is named after OPP Constable Laurie Hawkins, who died, along with her husband and two children, in her Woodstock home from CO poisoning in 2008.

“In Ontario, more than 80% of injuries and deaths from CO occur in the home,” said Alexander. “We want to make sure everyone is safe from CO. Install CO alarms, and do everything you can to prevent CO in your home in the first place.”

Homeowners and landlords are responsible for ensuring their properties have working carbon monoxide alarms. The law requires landlords to test CO alarms in rental units annually and when the battery is replaced. Testing is also required if changes are made to the electrical circuit or a change in tenancy occurs. Tenants are required by law to notify the landlord if the CO alarm is inoperable and it is against the law for tenants to remove the batteries or tamper with the alarm.

Can Emergency Services Find You ?

Fire, Police and Emergency Services depend on you as the homeowner to ensure your "911" sign or house number is clearly visible. Visible house numbers/911 signs could mean the difference between life and death.

Most importantly, please ensure you actually have a 911 sign or house number. The Township's By-law No. 1995-49 states "*owners of property keep and maintain in good condition their civic number plate or civic numbers, whatever the case may be, and shall be responsible for the costs associated with such maintenance or replacement*".

Looking for an address is very difficult particularly at night, in the fog, snow or rain. It is important that these numbers are easily visible at all hours of the day and all types of weather. Valuable time is wasted if emergency services need to look for the location.

A Few Tips....

Ensure your 911 signs or house numbers are in good repair and legible. If your 911 sign is damaged or missing, please contact the Township Office so a new one can be ordered.

For rural properties, the civic number plate is to be placed on its own post, within 3 metres of the property line and within 3 metres of the edge of the driveway, unobscured by any objects, and perpendicular to the fronting road.

The plate must be a minimum of 1.5 metres above grade, and a maximum of 2 metre above grade.**

For urban properties with existing civic addresses and a posted speed of 60 km or less, the numbers must be a minimum of 7" in height, or if reflective, 5", and must be clearly visible from the travelled portion of the road.

If your 911 sign becomes buried due to heavy snowfalls or snow removal operations, please clear around the sign to always ensure visibility.

When landscaping or decorating your front porch, do not obscure your 911 sign or house number.

Remember..... Emergency Services can't help you if they can't find you!

New Financial Fees Effective Jan 1, 2018

Tax Confirmation requested by Bank or Trust Company	\$15 per property	If your bank is requesting a tax confirmation letter that taxes have been paid, a \$15 fee per property will apply.
Tax Confirmation Letters	\$15 per property	If you require a confirmation letter to be printed confirming that taxes have been paid, a \$15 fee per property will apply NOTE: if you have a copy of your tax bill and want it stamped paid you can bring your bill into our office to be stamped and no fee will apply for this service.
NSF Fee or Returned Cheque/ PAP	\$25	If a cheque is returned or PAP payment is returned for insufficient funds, a \$25 fee will be applied to your tax account.
Payment Redistribution Fee	\$10 per tax roll number	If you pay for multiple properties on the same tax roll number and the payment has to be redistributed, a fee of \$10 per tax roll number will apply. When paying for multiple properties please enter each payment separately when paying online, using the tax roll number for each property as the account number. If payment for multiple properties is submitted to one tax roll number, it will only be applied to the tax roll number indicated. If you are paying by cheque for multiple properties, the payment can be on one cheque, but please submit the tear off stubs for each property.
Tax Bill Reprint	\$5 per bill	If you require a reprint of your tax bill, a fee of \$5 per tax bill reprint will apply.
