In the event there are an insufficient number of certified candidates to fill all positions available, nominations will be reopened for the vacant positions only on Wednesday, September 15, 2010, between the hours of 9 a.m. and 2 p.m. and such additional nominations, if required, may be filed in the office of the Clerk.

Electors are hereby given notice that if a greater number of candidates are certified than are required to fill the said offices, electors will be able to vote by mail during the voting period of September 28 to October 16, 2010, or by dropping off sealed ballots at the Township Office, Hickson, between the hours of 8:30 a.m. & 4:30 pm between the dates of September 28 and October 22, 2010, and on Voting Day between the hours of 8:30 a.m. and 8:00 p.m.
