(The Municipal Act, Sections 172 and 173)**

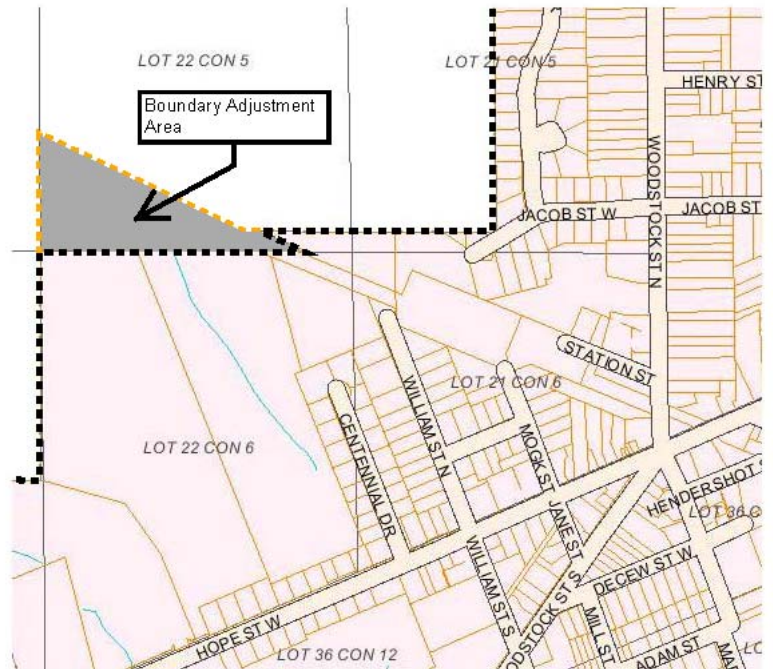

The Township of East Zorra-Tavistock and County of Oxford propose to expand its boundary to encompass lands in Lot 22, Concession 5, Township of Perth East (Formerly Township of South Easthope), County of Perth. The purpose of the proposal is to align property boundaries with municipal boundaries and to facilitate efficient and safer servicing of land proposed for development.
